## **ORDINANCE NO. 2024-2300**

AN ORDINANCE OF THE CITY OF NEW PORT RICHEY, FLORIDA, PROVIDING FOR THE SALE OF SURPLUS CITY PROPERTY; PROVIDING FOR THE SALE OF THE **PROPERTY** GENERALLY LOCATED AT 7440 US HIGHWAY 19, AS LEGALLY DESCRIBED BY PARCEL NUMBER HEREIN FOR THE PURCHASE PRICE OF \$39,000.00 TO LEE NGUYEN; PROVIDING AUTHORIZATION TO THE CITY MANAGER TO EXECUTE ALL DOCUMENTS IN ACCORDANCE HEREWITH: PROVIDING FOR AND **EFFECTIVE DATE.**
